Due to the large number of exhaustion patients being admitted to the Clr Sta, a Div Exhaustion Center was established in CARENTAN under the supervision of the Div Neuropsychiatrist (Maj BYRNES). The purpose of this center was to rest, treat, rehabilitate and return to duty as many exhaustion patients as possible without evacuating them farther to the rear and administratively losing them from divisional control.

Casualties transferred to 2d Plat, 42d Field Hosp and to 34th, 67th, 91st, 96th, 128th Evac Hosps. Exhaustion patients transferred to 622d Clr Co (Sep).

Casualties in this organization: 2 EM WIA (Tec 5 Schmalzbauer, Co B Pfc Bozarth, Co B).

Casualties admitted to Clr Sta: 289.
