D. Changes of station: Company left Camp Breckinridge, Kentucky 25 March 1944 enroute to staging area and arrived at Camp Shanks, New York 27 March 1944. Left Camp Shanks, New York Port of Embarkation 6 April 1944 in three detachments and boarded USAT George Washington, HMS Orian and HMS Samaria and arrived at Liverpool, England 18 April 1944. Stationed at Keele Hall, England. Left Keele Hall, England 16 June 1944, arrived Winchester, England 17 June 1944 and boarded ship at Southampton 18 June 1944. Landed at Omaha Beach, France 24 June 1944. Served in France from 24 June 1944 to 25 September 1944. Served in Luxembourg from 24 September 1944 to 6 December 1944. Served in Germany from 7 December 1944 to 26 December 1944. Served in Belgium from 27 December 1944 to 31 December 1944.

E. Marches: All foot marches made were of short duration in all kinds of weather for the purpose of training. Longest motor marches made in convoy were as follows: 330 miles from Boigny, France to Kockelschever, Luxembourg.

125 miles from Luxembour Luxembourg to Aachen, Germany. 90 miles from Aachen, Germany to Havelange, Belgium. All other motor marches were of short duration for the purpose of obtaining supplies and short moves to new bivouac areas.

The 83rd Signal Company was bivousced in the vicinity of Vierville, France in the rear echelon of the 83d Infantry Division. During the drive through the bottle neck South of Carentan, the construction section installed and maintained communications throughout the dividion. They were laying spiral four cable and regular field wire. During one move they laid 85 miles of field wire alone. This was a tremendous amount of wire and communications to maintain with the amount of men the section had, so they received some replacements to supplement their platoon. During the entire month they laid approximately four or five hundred miles of spiral four cable. The Telephone and Telegraph Section was kept busy installing and operating the switchboards and local lines within both the forward and rear CPs. The Message Center Section serviced anywhere from 100 to 130 outgoing messages per day and approximately as many incoming messages. The Message Center Section operated a 24-hour message center both at the forward and rear CPs. The Radio and TaT Repair Sections and maintenance section repaired radies, switchboards and telephones; not only for the company itself but for the whole division. The Division Signal Supply section kept the signal supplies flowing rapidly and replacing supplies for the division. The rest of the company carried on their normal duties of supply and administration, repairing of company vehicles and messing.

1. In compliance with Ltr. Hq FUSA, file 319.1/401 (c), dated 13 July 1944; and par. 10, C3, AR 345-105, 9 March 1943, the following report is submitted herewith:

The 83d Signal Company was bivouaced in the vicinity of Bricqueville, France on 24 June 1944. The company was elected for movement on 27 June 1944 and moved to the vicinity of Vierville, France in the rear echelon of the 83rd Infantry Division which was at this time relieving the 101st Airborne Division in the Carentan Sector. The Division then consolidated its position and began preparations for an offensive operation South of Carentan. The operations platoon installed and maintained communications within the division and to attached units. The Message Center section was in 24 hour operation from the Division Command Post and also from the Rear Echelon Command Post. The Division Signal Supply was busy bringing the signal supplies of the division up to their normal strength. The other sections of the company had no operational duties at the time, with the exception of normal administration functions.
