I--AWARD OF BRONZE STAR MEDAL (Posthumous Award)--Under the provisions of AR 600-45, as amended by letter, Headquarters ETOUSA, AG 200.6 MP, subject: "Bronze Star Medal," 27 February 1944 and in accordance with authority contained in paragraph 1d Memorandum No. 34 Headquarters Ninth United States Army, APO 339, 8 September 1944, the Bronze Star Medal is awarded to the following:

III--AMENDMENTS TO GENERAL ORDERS.


